It is time to start thinking about those people who deserve to be nominated for recognition awards. When you are honoring a fellow volunteer worker, you are letting them know just how much you appreciate them, and how much their work means to you, their club, and our national organization.

Send your nominations for recognition awards to your Regional Director, with the exception of the President's Award, which should be sent to the AVA President. The nomination guide on how to complete the forms can be found on the AVA web site under:

<u>Administrative – General Admin – Publications / Policies – AVA Recognition Awards program – Guide for nominations</u>. You will need to use one form for each person nominated. The award is based on what is written on the form, so please be thorough. The more detailed information you can give will help the committee review each nomination. The following are forms to be used: <u>Form 302</u> - Hall of Fame, Distinguished Achievement, Trailblazer, and Ted Ballman Memorial Youth Award (Submit to Regional Director for submission to Awards committee)

Form 303 - Certificate of Service, Meritorious Service and Certificate of Appreciation (Submit to

Regional Director)
Form 303 PA - President's Award (Submit directly to AVA President)

IMPORTANT—Accident Notification Information

Changes made to "Emergency Notification Information"—the August 2011 tragedy in the NE Region which prompted the NEC remedy to such events has changed to provide that the word "emergency" be changed to "accident."

The now, "Accident Notification" information should include the POC's cell number and also that of the RD. AVA headquarters has included this "Accident Notification Box" on the website under the Administrative tab—General Admin—Graphics & Logos, available for download as a .pdf or .jpg file, in which contact information can be added and then inserted into event materials. When preparing walk instructions for "traditional events," clubs should always determine and include in the instructions which Emergency Services are available, as "911" does not always work in all communities where we schedule walk/sporting activities.

These procedures will be added to Standards and Procedures Manual once they are finalized. These procedures do not replace the incident report that must be sent to HQ.
