It is time to start thinking about those people who deserve to be nominated for recognition awards. When you are honoring a fellow volunteer worker, you are letting them know just how much you appreciate them, and how much their work means to you, their club, and our national organization.

Send your nominations to your regional director, with the exception of the President's Award, which should be sent directly to the AVA President. The nomination guide on how to complete the forms can be found on the AVA web site under: Awards. Please use one form for each person nominated. Be thorough, the award is based on what you have written on the form. The more detailed information you can give will help the committee review each nomination.

Form 303 Certificate of Service, Meritorious Service, and Certificate of Appreciation.

AVA.org Website Update & ESR Changes

As many of you experienced when attempting to submit Quarter 1 participation reports, the AVA.org website was not functioning. The system went down due to an attack on the service provider who hosts the website. We apologize for this inconvenience and have since migrated the site to a new hosting provider. The site migration has caused some additional temporary hiccups as files have been syncing and additional maintenance performed. All links have been set with redirects that should populate within 48 hours; however, we have been informed that older operating systems might not automatically update saved links (e.g. to ESR page). If you are still receiving error messages in the next few days, and run a Windows machine, these instructions will allow you to manually refresh DNS settings.

Refresh DNS settings by pressing and holding the Windows-Key, then pressing the R key before releasing both keys. This will open the Run window. In the run window type: ipconfig /flushdns (there is a space between the first word and the slash) and then click OK to run the command.

Reminder—Clubs should update Club and event (traditional, seasonal, and YRE event) changes through the Club Maintenance ESR system, which then automatically populates the changes into the website event listings. If you encounter problems making changes contact your Regional Director first who will then determine if headquarters needs to be contacted for further action. Event listing changes include any updates that need to be made for basic facts such as event date/time, location, and start point info.

After a change is completed, please email Marie Bebley at events@ava.org. Marie then updates the events records and communicates that the changes need to be added to the Start Point Changes web page which serves as a compilation of all the 2014 updates that have been made through the ESR system.
